Circus and Physical Theatre Producer/s – Expressions of Interest

Performing Lines is seeking Expressions of Interest for the engagement of a CaPT Producer/s to plan and deliver a Victorian CaPT residency program and to support a number of artists and/or small circus and physical theatre companies in the state.

Working closely with Performing Lines' Senior Producer – Vic, the successful applicant/s will have excellent producing and relationship management skills, with a strong understanding of the CaPT sector in Victoria, including the needs of artists in developing, presenting and touring work.

In total we have a 0.8FTE (4 days per week) workload between August 2024 and June 2025. Contact hours, duration and workload will be negotiated by mutual agreement with the successful applicant/s.

The role is based at the Performing Lines Vic office in Collingwood Yards. From time-to-time the role will require work outside of regular office hours.

We support flexible working practices and infrastructure, including hybrid working arrangements, to promote work-life balance and to meet the diverse and unique needs of each employee.

Performing Lines embraces difference and seeks to foster increased inclusivity and representation in the art that we create, the audiences we attract and the staff we engage. We recognise the value of diverse experience, perspectives and practice and acknowledge these experiences as a specialist expertise. First Nations applicants and those from communities typically under-represented within our sector are strongly encouraged to apply, and applicants are encouraged to speak to their lived experience and networks as part of their application.

POSITION SUMMARY:

Reporting to the Senior Producer, the Producer is responsible for driving the planning and/or delivery of key Circus and Physical Theatre projects for Performing Lines.

KEY RESPONSIBILITIES:

- Manage and coordinate all aspects of developments, presentations, sector development initiatives and/or tours within allocated budgets, including:
 - o developing grant and/or other applications or proposals
 - o drafting project budgets and preparing presentation quotes for management sign off
 - o organising logistics such as transport, accommodation, visa processes, etc
 - o liaising with presenters / partners on creating and updating key schedules (incl. marketing, production, engagement programs etc), contact lists, tour books, etc
 - o ensuring all key project team members (e.g. Marketing Manager, Production Manager, Key Artists) are abreast of project updates and understand key deadlines
 - ensuring technical requirements are understood and delivered by each presenter, working closely with Performing Lines' Production Manager
 - drafting employment and presenter contracts with artists and creatives for management sign off
 - ensuring all royalties, necessary copyright and industry agreements are organised, agreed and paid
 - monitoring budget and monthly reporting financial reporting
 - coordinating debriefs and evaluations and contributing to project reports and grant acquittals
 - supporting the creation of production documentation, including technical specifications, marketing kit and budget templates, and ensuring they are kept up-to-date and reflect the production requirements, working closely with the Executive Producer, Senior Producer, Senior Production Manager, Marketing Manager and General Manager
- Establish and maintain successful working relationships with key stakeholders including Performing Lines team members, artists, arts organisations, festivals, producers, presenters, marketers, technicians, private supporters and government funding agencies.
- Support the Senior Producer & Executive Producer to identify and negotiate new opportunities for work including, contributing to grant and market development applications and liaising with presenters, artists and other industry partners.
- Attend opening nights / theatre performances / industry events on a regular basis and as agreed with the Senior Producer.

SKILLS REQUIRED:

- Considerable experience producing performing arts productions, presentations and tours, experience producing new work and/or international producing experience is preferred but not essential
- Impeccable organisational and time management skills, displaying confidence and efficiency when working to tight and/or competing deadlines
- Excellent communication and interpersonal skills with demonstrated ability to develop and manage strong relationships
- Ability to work with artists from a diverse range of backgrounds and lived experience

- Proven strong stakeholder management and negotiation skills
- Demonstrated ability to work effectively and harmoniously with artists and creative teams
- Proven ability to manage budgets and to apply cost-saving mechanisms where required
- Demonstrated ability to write successful grant and funding applications
